### **RESOLUTION NO. 23-46**

### RESOLUTION TO RESCIND RESOLUTION 23.33 TO AWARD A CONTRACT TO HFT MANAGEMENT, INC. DBA GATEWAY OUTDOOR ADVERTISING FOR TRANSIT ADVERTISING, SALES, PRODUCTION, AND REMOVAL

**WHEREAS,** MATA staff solicited proposals from companies for Marketing Transit Advertising Sales, Production, Installation, and Removal under which the companies would provide advertising and related services and MATA would receive a portion of the revenues; and

**WHEREAS,** MATA's Evaluation Committee reviewed proposers' technical proposals and financial proposals, conducted interviews, and performed background checks; and

**WHEREAS,** The Evaluation Committee recommended that the award of a contract to HFT Management (DBA Gateway Outdoor Advertising) was in the best interests of MATA considering qualifications/experience, innovativeness, methodology and technical approach, management plan, scope of work, community engagement experience, and approach to long term financial growth and financial sustainability; and

**WHEREAS,** Upon further review by MATA staff has determined that the Request for Proposals (RFP) is not clear to potential proposers in certain respects; and that the overall proposals received to be inadequate as to MATA's needs and that a new procurement action should be initiated and include clearer evaluation criteria and scoring categories; and

**WHEREAS,** the determination by MATA staff of proposers' failure to adequately provide documentation and certification forthwith that either entity has secured and will comply with the Disadvantaged Business Enterprise (DBE) contract goal as determined by the proposal; and,

NOW THEREFORE, BE IT RESOLVED BY MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS, That Resolution 23-33 be rescinded, and that any offer implied or stated is also rescinded.

**BE IT FURTHER RESOLVED,** That MATA will reissue the RFP based on recommendations and review of the General Counsel and MATA staff.

**BE IT FURTHER RESOLVED,** That the Chief Executive Officer, Deputy Chief Executive Officer, Chairman or Vice-Chairman of the MATA Board of Commissioners is authorized to execute the rescission of Resolution 23-33 and related documents.

MATA staff solicited proposals from companies for Marketing transit advertising sales, production, installation, and removal of advertising on behalf of MATA.

The evaluation team determined that HFT Management (DBA Gateway Outdoor Advertising) would operate in the best interest of MATA. However, upon further review, MATA staff determined that there was a failure in the scoring and issues with meeting the DBE requirements.

It was also determined that MATA staff, through further investigation, that there were actions that were deemed inappropriate by vendors that were not adequately addressed and believed disqualifiable under MATA's fair bidding process.

MATA staff will revise the procurement later to include terms and conditions concerning vendors and any disqualifiable actions while going through the bidding process as well as address any bids that do not meet the strict adherence of the DBE requirements as indicated in the procurement.

### RESOLUTION TO AWARD A CONTRACT TO ZELLNER FOR INSTALLATION OF THREE BUS CHARGING STATIONS

**WHEREAS,** The Memphis Area Transit Authority (MATA) is a public agency responsible for providing public transportation services within the City of Memphis and surrounding communities; and

**WHEREAS,** Bids were solicited from vendors in accordance with MATA's Procurement Policies including formal advertisement; and

WHEREAS, Three bids were received and evaluated by MATA's staff; and

**WHEREAS,** MATA's staff recommends that a contract for the installation of three bus charging stations be awarded to Zellner Construction Company Inc., who submitted a responsive and responsible bid, in an amount of \$439,306.00; and

WHEREAS, MATA has Federal, State and Local capital funds for this project.

This procurement was formally advertised, published on MATA's website, and an Invitation for Bids was sent to seven vendors.

The goal for participation by Disadvantaged Business Enterprise (DBE) was set at 26.24%.

Three responsive bids were received as follows:

A & B CONSTRUCTION CO.	\$615,896.34
YORK CONSTRUCTION SERVICES	\$749,992.88
ZELLNER CONSTRUCTION CO.	\$439,306.00

Zellner Construction Company, Inc. submitted a responsive responsible bid in the amount of \$439,306.

The subcontractor for this project is A1 Electric. A1 Electric is a 100% DBE company. MATA has worked with Zellner Construction Company on several projects and their work has always been determined acceptable. They have indicated that they can meet the period of performance of 120 days after Notice to Proceed.

MATA's Staff recommends that a contract be awarded to Zellner Construction Company, Inc. for the Installation of Three Bus Charging Stations in the amount of \$493,306.00.

### **RESOLUTION TO APPROVE DECEMBER 2023 SERVICE CHANGES**

**WHEREAS,** MATA makes service changes periodically to increase efficiency and effectiveness of service and to align service levels with available manpower and funding; and

WHEREAS, The proposed set of changes were made available for public comment by providing notices to the Daily Memphian, Commercial Appeal, Memphis Flyer, and La Prensa Latina. In addition, the information was shared via the MATA website, at all three MATA Transit Centers, Omnilert (a customer communications tool which customers can subscribe to receive real-time information), frequent posts on MATA social media platforms and the City of Memphis NextDoor app, reshared/retweeted by several community organizations, and shared by multiple news outlets; and

**WHEREAS,** 12 public meetings were held throughout the MATA service are during the week of October 16-21<sup>st</sup> to provide riders and citizens an opportunity to submit comments in addition to the normal public comment period; and

**WHERAS**, Staff recommends that the change summarized in Appendix A be approved for fixed-route bus and trolley service; and

**WHEREAS,** Comments from riders and citizens in the community have been considered and are summarized in Appendix B with responses; and

**WHEREAS,** The recommended changes are consistent with the goals and recommendations of the Transit Vision that was adopted by the MATA Board of Commissioners on January 29, 2019; and

**WHEREAS,** The proposed changes have been reviewed according to MATA's Title VI policies, adopted on March 25, 2013, and a service equity analysis was performed to determine whether the new service would have adverse effects, potential disparate impacts, or disproportionate burdens to minority or low-income populations; and

**WHEREAS,** It has been determined that there will be no adverse effects, potential disparate impacts, or disproportionate burdens to minority or low-income populations associated with these proposed service changes; and

WHEREAS, Staff recommends that said changes be effective on December 3, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS, that said service changes are approved to be effective December 3, 2023.

The purpose of this resolution is to approve proposed service changes to take effect December 3, 2023. These changes are needed to improve reliability, on-time performance, and address manpower and operational funding challenges.

The proposed changes include having a minimum frequency of 60 minutes on all fixed-route buses on weekdays and Saturdays, 120 minutes on Sundays, and the suspension of all service after 7 pm on weekdays, Saturdays, and Sundays. Service on several routes with low ridership will be suspended on weekdays, Saturdays, and Sundays as well. Please see Appendix A for a list of for a detailed list of the proposed changes.

These changes to the fixed-route system will impact MATAplus service, resulting in the suspension of service after 7 pm. Some other areas of the MATAplus service area will be impacted by the suspension of service on the fixed-route service.

MATA's On-Demand Ready! service will be expanded in the Frayser Zone 2 and Cordova Zone 3 to help cover service suspension to Route 32 and Route 19.

The proposed changes have been reviewed according to MATA's Title VI policies and a service equity analysis has performed to determine whether the new service would have adverse effects, potential disparate impacts, or disproportionate burdens to minority or low-income populations. The results confirmed that there will be no adverse effects, potential disparate impacts, or disproportionate burdens to minority or low-income populations associated with these proposed service changes.
