# RESOLUTION TO AWARD A CONTRACT TO ZELLNER FOR EAST MADISON AVENUE TRACK PAVEMENT REPAIR

**WHEREAS,** The Memphis Area Transit Authority (MATA) is a public agency responsible for providing public transportation services within the City of Memphis and surrounding communities; and

**WHEREAS,** Bids were solicited from vendors in accordance with MATA's Procurement Policies including formal advertisement; and

WHEREAS, One responsive bid was received and evaluated by MATA's staff; and

**WHEREAS,** MATA's staff recommends that a contract be awarded to Zellner Construction Company Inc., who submitted a responsive and responsible bid, in an amount of \$640,632.12; and

WHEREAS, MATA has Federal, State and Local capital funds for this project.

**NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS** That a contract be awarded to Zellner Construction Company Inc., for the East Madison Avenue Track Pavement Repair in the amount of \$640,632.12 and a time of completion of 120 days from Notice to Proceed.

**BE IT FURTHER RESOLVED** That the Chief Executive Officer, Chief of Staff, Chairman or Vice-Chairman be authorized to execute the necessary contract.

**SUBJECT:** East Madison Track Pavement Repair

This procurement was formally advertised, published on MATA's website, and an Invitation for Bids was sent to 11 vendors.

The goal for participation by Disadvantaged Business Enterprise (DBE) was set at 28%.

One responsive bid was received as follows:

ZELLNER CONSTRUCTION CO.

\$685,632.12

Zellner Construction Company, Inc. submitted a responsive responsible bid in the amount of \$685,632.12. MATA staff negotiated with Zellner Construction concerning pricing and supply delivery. It is determined that the shipping and receiving of material needed could not meet the project timeline. MATA staff agreed to change the liquidated damages timeframe from 60 days to 120 with a \$45,000 reduction in cost for the project. The new proposal cost comes in at \$640,632.12

The subcontractor for this project is Mallard Construction LLC. Mallard Construction LLC is a 100% DBE company. MATA has worked with Zellner Construction Company on several projects and their work has always determined acceptable. They have indicated that they can meet the period of performance of 120 days after Notice to Proceed.

MATA's Staff recommends that a contract be awarded to Zellner Construction Company, Inc. for the East Madison Avenue Track Pavement Repair in an amount of \$640,632.12.

# RESOLUTION TO AWARD A CONTRACT TO A & B CONSTRUCTION FOR THE POWERHOUSE DEMOLITION PROJECT

**WHEREAS,** The Memphis Area Transit Authority's Trolley Division (MATA) must demolish a three story 100 year old electrical power plant structure located on the Northeast corner of the Main Street Trolley Barn facility; and

**WHEREAS,** MATA issued an Invitation for Bid (IFB) for companies to provide demolition project and one responsive and responsible bid was received; and

**WHEREAS,** Staff has reviewed the bid received and initiated negotiations with A&B Construction. MATA staff were able to negotiate the contract from the original cost of \$179,375.00 to \$141,148.92.

**WHEREAS,** MATA staff negotiated with A&B Construction to reduce the cost of the project to a total cost of not to exceed \$141,148.92.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS That a contract be awarded to A & B Construction at a cost not to exceed \$141,148.92 for the Powerhouse Demolition service.

**BE IT FURTHER RESOLVED** That the Chief Executive Officer, Chief of Staff, Chairman, or Vice-Chairman be authorized to execute the contract.

**DATE:** August 23, 2022

**SUBJECT:** Powerhouse Demolition Project

The Memphis Area Transit Authority Trolley Division wants to demolish a three-story, 100-year-old electrical power plant structure located on the Northeast corner of the Trolley Barn facility in order to make space for future Trolley development. This project will include the demolition of the structure, along with back fill and leveling of the existing ground.

MATA issued an Invitation for Bid (IFB) for demolition services. This procurement was sent to 24 vendors, advertised and posted to MATA's website. The DBE goal for this procurement was set at 28%. One responsive and responsible bid was received. MATA staff reviewed the bid on the criteria set forth in the IFB.

MATA Staff has reviewed the bid received and initiated negotiations with A&B Construction. MATA staff were able to negotiate the contract from the original cost of \$179,375.00 to \$141,148.92, which is a reduction of \$38,226.08 in total contract cost.

MATA staff recommend that a contract be awarded to A & B Construction for the Powerhouse Demolition project at a cost not to exceed \$141,148.92.

#### **RESOLUTION 22-45**

#### **RESOLUTION TO APPROVE CAPITAL BUDGET FOR FISCAL YEAR 2023**

**WHEREAS,** MATA has rolling stock, buildings, equipment, facilities, and systems that are in need of replacement, refurbishment or improvements from time to time in order for MATA to continue to provide a reliable, safe, accessible, clean and customer-focused public transportation system; and

WHEREAS, Capital projects are typically funded by federal/FTA grants, along with state/TDOT, County, and City of Memphis matching funds; and

**WHEREAS,** Preventative maintenance and ADA paratransit service will be funded with capital grants and are included in the Fiscal 2023 Operating Budget; and

**WHEREAS,** Fiscal Year 2023 and prior year grant funds and matching funds are expected to be adequate to fund the Capital Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS That the Fiscal Year 2023 Capital Budget is approved at a level of \$34,658,700.

**BE IT FURTHER RESOLVED,** That the Chief Executive Officer or their designee is authorized to execute contracts and file grant applications for the funds to fulfill the capital program.

**BE IT FURTHER RESOLVED,** That Staff is authorized to manage line items as appropriate and make reports to the MATA Board at appropriate times.

MATA's Capital Budget for Fiscal Year 2023 includes major projects valued at over \$50,000 (which will require individual Board Action at the time of the project) and various smaller projects of lesser value. Procurement of all approved projects will conform to the MATA Procurement Manual. The total Capital Budget for FY 2023 is \$34,658,700.
