SUBJECT: Purchase One 2022 or Newer Wrecker

This memo summarizes the procurement process to secure a vendor to purchase one 2022 or newer wrecker for MATA's Bus Maintenance Department.

MATA solicited bids for this project from five vendors, and the solicitation was formally advertised and placed on MATA's website. One bid was received.

Rush Truck Center was deemed responsive and responsible.

The Disadvantaged Business Enterprises (DBE) goal was set at 0%.

Staff recommends that a contract be awarded to Rush Truck Center to purchase one 2022 or newer wrecker at a cost not to exceed \$554,868. They stated on their bid the chassis lead time is 360 days from Notice to Proceed.

RESOLUTION TO AWARD A CONTRACT TO ADSPOSURE FOR MARKETING TRANSIT ADVERTISING SALES, PRODUCTION, INSTALLATION AND REMOVAL

WHEREAS, The Memphis Area Transit Authority (MATA) solicited proposals from companies for Marketing Transit Advertising Sales, Production, Installation and Removal under which the companies would provide advertising and related services and MATA would receive a portion of the revenues; and

WHEREAS, MATA received two responsive bids that offered bus advertising services; and

WHEREAS, MATAS Evaluation Committee reviewed the two proposals and used a weighted scoring methodology that measured respondents qualifications and experience, methodology and technical approach, management plan, schedule, and scope of work; and

WHEREAS, MATA's Evaluation Committee reviewed bidders financial proposals, conducted interviews, and performed background checks;

WHEREAS, The Evaluation Committee recommends that award of a contract to ADSPOSURE was in the best interests of MATA considering qualifications/experience, innovativeness, methodology and technical approach, management plan, scope of work, community engagement experience, and approach to long term financial growth and financial sustainability; and

WHEREAS, ADSPOSURE has committed to DBE participation of 15%; and

WHEREAS, Staff recommends that a contract be awarded to ADSPOSURE for a period of three-years with one three-year option, subject to final negotiations.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS That a three-year contract with a three-year option for transit advertising be awarded to ADSPOSURE at a Minimum Annual Guarantee of \$175,000 the first year, for the second year \$200,000, and the third year \$200,000 and \$200,000 per year for years four, five and six; and Net Revenues of 50/50% share ratio.

BE IT FURTHER RESOLVED That the contract award is contingent on successful completion of negotiations on contract terms.

BE IT FURTHER RESOLVED That the Chief Executive Officer, Chief of Staff, Chairman or Vice-Chairman be authorized to execute the necessary contract.

SUBJECT: Marketing for Transit Advertising Sales Production, Installation, and Removal

MATA issued a Request for Proposal on March 2, 2022, for companies to provide services related to bus advertising. The term of the contract was anticipated to be 3 to 6 years. Two responsive bids were received, and the evaluation committee reviewed and scored proposals based on weighted scoring criteria contained in the RFP, interviews were conducted, and references and background checks performed. This memo provides additional background information and a recommendation for bus advertising.

The Disadvantaged Business Enterprise (DBE) goal was set at 15%.

Based on the outcome of weighted scoring criteria contained in the RFP to include reference checks, interviews, and financial sustainability and growth the evaluation committee recommends awarding of a contract to ADSPOSURE for a period of three years with a three-year option.

WHEREAS, The Memphis Area Transit Authority (MATA) Board of Commissioners awarded a Contract for Two-Year w/One-Year Option to Pro-Touch Services, Inc. by Resolution 22-13 on May 4, 2022; and

WHEREAS, MATA Staff has determined that additional cleaning staff is needed to clean and sanitize the Administration and Operation office at 1370 Levee Road to MATA standards: and

WHEREAS, MATA will eliminate COVID cleaning services at 444 N. Main St., the Hudson Transit Center location and will add the Hudson Transit Center to the existing janitorial contract; and

WHEREAS, A quote was requested from the existing vendor, Pro-touch to incorporate additional staff and modified hours to better serve the Levee Road location. MATA staff also requested pricing to a add the Hudson Transit Center to the existing contract; and

WHEREAS, MATA staff has determined that Pro-touch has submitted a fair and reasonable quote; and

WHEREAS, MATA staff recommends approval of Change Order #1 to Pro-Touch Services, Inc. to add additional cleaning staff and modified hours for the Levee Road location. MATA staff also recommends approval of adding the Hudson Transit Center to the existing contract. This will increase the current two-year w/one-year option contract by \$140,520.00 for the two-year base period and \$210,780.00 if the one year option is enacted, making the current contract not to exceed \$272,088.00 for the two-year base period and \$408,132.00 if the one-year option is enacted; and

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS That Change Order #1 be approved to Pro-Touch Services, Inc., with an amount not to exceed \$272,088.00 for the base two-year base period and \$408,132.00 if the one-year option is enacted through the remaining contract period.

Contract for Janitorial Services

MATA approved a contract for Janitorial services to maintain the American Way Transit Center and Levee Road Administration and Operation building on May 4, 2022, by Resolution 22-13. After the contract was in place and services began, it was determined by MATA staff, that additional cleaning staff would be needed to better serve the Levee Road location. At this time, it was also determined by MATA staff that COVID cleanings at Hudson Transit Center would be ending and would need to be added to the existing janitorial contract.

MATA Staff reached out to the existing vendor, Pro-touch, for quotes on Levee Road and Hudson Transit Center. MATA staff determined that the quotes provided were fair and reasonable. The original contract was approved at \$131,568.00 for the two-year base period and \$197,352.00 if the one-year option was enacted.

With the Levee Road amendment and Hudson Transit Center addition, the contract will increase by \$140,520.00 for the two-year base period and \$210,780.00 if the one-year option is enacted. The new changes will make the current contract at a total cost not to exceed \$272,088.00 for the two-year base period and \$408,132.00 if the one-year option is enacted.

SUBJECT: Purchase of seven (7) Siemens U2 LRV Cars

This memo summarizes the steps followed and final decision to purchase seven (7) Siemens U2 Light Rail Vehicle Cars (LRV Cars) from Virginkar & Associates, Inc., serial #'s 1033, 1066, 1010, 1048,1049, 1052, and 1026.

In 2021, MATA purchased a single 1988 Siemens U2 Light Rail Vehicle (LRV), serial # 1035 to conduct feasibility, viability, and integration testing (U2 Car Integration Testing) of a modern streetcar design on MATA's Madison Line rail system as part of the Madison Line's revitalization and safety recertification project.

MATA performed inspections, maintenance, and service testing of the U2 LRV Car, track, roadbed, substations to ensure safety during the U2 LRV car integration testing. These efforts included a comprehensive inspection of the Madison Line rail track and roadbed, a key component of the test.

From the track inspection report, MATA completed partial, necessary, and adequate repairs to the track, switches, and special trackwork to ensure a safe operating level for U2 LRV Car integration testing only. MATA put in place track safety standard requirements, schedules, plans, and procedures to ensure conformance with applicable track safety standards for the parameters of each testing procedure. Note: Further work will be necessary to further inspect and repair track to achieve a full operating condition as part of the Madison Line revitalization and recertification project.

MATA also performed necessary inspections, maintenance, and testing of the Madison line's two (2) power substations and overhead catenary system (OCS) systems to ensure that adequate power and safeguards were in place. MATA worked closely with representatives of MLGW, City of Memphis, and other stakeholders as we powered up, tested the substations, OCS, and negative track return before and during integration testing of the U2 LRV Car. Note: Further work will be necessary to fully inspect and repair of the substation and OCS systems to achieve a full operating condition as part of the Madison Line revitalization and recertification project.

Working with the City of Memphis, Memphis Police Department, Memphis Fire Department, and other stakeholders to prepare and inform the public of the U2 LRV Car Integration Testing event, schedule, locations, and safety risks. The public awareness campaign included safety, security, and emergency readiness preparations. Other activities include, but were not limited to, removing or clearing of debris, obstacles, persons, and other risks prior to, and during, integration testing events.

U2 LRV Car Integration Testing parameters, procedures, and checklists were discussed, developed, and scheduled through a collaborative process formalized into U2 Car Integration Testing Task Team, with key representatives from MATA, City of Memphis, MLGW, MPD, MFD, and other stakeholders. Gary Rosenfeld directed MATA's COO and CSSO to lead the effort at the senior executive level, with the Director of Trolley Operations, MATA's Administrator, and support from a Project Director to facilitate project planning, timetables, meetings and execution of the integration testing activities. Testing activities included, but were not limited, to clearance, rail to wheel interface, braking, station integration, slow speed, emergency stopping, high speed, station to LRV car placement (measurements), substation power draws, stray current, ADA assimilation, pantograph to OCS wire contact, and other testing activities, as applicable.

MATA concluded that integration of the U2 Car into MATA rail operations is feasible, viable, and achievable for the Madison Line, and other lines, with manageable, and readily attainable revitalization and refurbishing efforts to the U2 LRV Cars, and Madison line track, stations, substations, repair facilities, and other subsystems.

MATA assigned the COO and CSSO to inspect and assess the condition of the seven (7) Siemens LRV cars located near San Diego, California. The COO and CSSO inspected the condition of the LRV's with the owner, an engineering consultant, and others with experience in LRV purchase, servicing, and certifications. Five (5) [#'s 1033, 1066, 1010, 1048,1049] of the seven (7) LRV cars were wrapped and in similar condition to the 1988 Siemens U2 LRV car serial # 1035, purchased in 2021.

Two (2) of the seven (7) LRV's wraps had been torn off by vandals, with graffiti sprayed on the outside of the cars, and damage to some of the windows. The inside of each had minor to no damage at the time of our inspection. We estimated graffiti and damage to be about \$50,000, which the owner agreed to reduce the price to offset the damage. The two damaged cars may be used for spare parts or, at our option, can also be restored.

After completing U2 LRV car integration testing and purchasing due diligence inspections, each of MATA's senior executives and the CEO decided to move forward with the purchase of the seven (7) Siemens U2 Light Rail Vehicle cars from Virginkar & Associates, Inc.; serial #'s 1033, 1066, 1010, 1048,1049, 1052, and 1026, for the total discounted price of \$841,800 which includes: U2 Car drawings, parts, handling, storage, shipping, security, and delivery by freight rail to Tallulah, Louisiana.

MTA believes the introduction of modern LRV streetcars into its services will be highly beneficial to businesses, public, students, and visitors to Memphis as it provides a dynamic and effective means of transporting people comfortably, reliably, and safely along Madison Avenue.

Contracting Department and Activity. The Trolley Department seeks to purchase by means other than full and open competition seven (7) U2 Light Rail Vehicles (LRV). The agreement has a 10 percent hold back retainage of \$84,180.00 to ensure delivery of vehicles and spare parts to Tallulah, Louisiana, and inspection upon arrival. The shipping cost are included in pricing. The trolleys will be housed until rehab begins.

Statutory Authority. The proposed action may be awarded without full and open competition under the authority of the MATA Board based on Single Source definition which states "purchases from one selected supplier, even though there are other suppliers that provide similar products can be obtained if:"

- The item is available only from a single source or is limited purchased item.
- Extenuating circumstances¹ will not permit a delay of procurement to allow for full competition

Rationale Supporting Use of Citation in Statutory Authority. Based on the immediate action of Trolley to regain presence in the Memphis area, it was determined that the current MATA trolleys need much repair. MATA Trolley staff considered the current state of the trolleys and the much-needed repairs and determined that the existing assets did not meet the safety standards based on certifications provided by TDOT.

The current Trolley staff feels that it is necessary to restore and upgrade the current trolley system to include the purchase of new (slightly used) trolleys that may need minimum to full rehabs based on the current condition of the trolley. The condition was verified by MATA staff and determined that cost wise the proposed trolleys are in better working condition overall.

After investigation, it is also determined that purchasing these trolleys will keep the standards set for having the upgraded trolleys that are needed to ensure that MATA trolley lines remain operational which includes repairing existing lines and purchasing more updated trolleys that will operate more efficiently.

Other information. Provide any other facts supporting the use of other than full and open competitive, such as: MATA has not had a trolley system upgrade in over 10 years. Our current trolley system and infrastructure is in much need of rehab. In the past, repairs performed were on an as-needed basis. MATA trolley infrastructure is deteriorating, and a complete overhaul of the trolleys system including the purchasing the trolley cars will allow this to happen.

As for the trolley purchase, there was on a timeframe in which solicitation of the procurement would have exceeded the actuated timeframe between gaining seven (7) trolleys and the additional parts and plans verses having to take a three-to-six-month procurement process for the purchase to take place. The seller was anxious to sell because of a lease ending date that comes up in less than 20 days.

¹ Extenuating circumstances – Seller is liquidating assets with limited timeframe. MATA had to purchase or the trolleys would have been salvaged.

Efforts to Identify Additional Sources: As addressed in previous sections, MATA Trolley researched several sites and determined the level of difficulty in finding what would be compatible to what MATA needed. As time passed it presented more difficult to locate used trolleys that were compatible with our current needs. There is no federal funding attached to the procurement; therefore, the process allows for noncompetitive-single source procurement based on City of Memphis

Future Plans to Permit Competition. MATA will investigate the possibility of new vendors after four years. The recommendation is that MATA Trolley begin looking for new possibilities in the year 2026 to determine if the current trolleys still meet MATA's needs.

Recommendations and Certification of Sole Source. Based on the above, I recommend this acquisition be conducted on the basis other than full and open competition. I certify based on information provided that the Siemen U2 Light Rail Vehicles (LRV) to include the Additional Spare Parts, and Drawings is ordered from Virginkar & Associates.
