- Trolley restart Grand Opening was Monday April 30, 2018 at 11:00am at 547 N. Main Street. Everyone was invited.
- Civility Training is underway, and all MATA employees are required to attend.
- OTP: 19 Bus operators received 90%; 2 Trolley operators received 90%; and 20 MATAplus operators received 95% OTP in March 2018.
- Ridership continues to be down following the national trends, the biggest drop being evening and weekend service.
- OTP for all modes: Fixed Route 75%; Trolley 82%; and MATAplus 94%.

- Passenger Complaints per 100,000 boarding for all modes received a nice drop in complaints. ACTION: Mr. Rosenfeld stated that staff will get this calculated for legibility and better understanding and report back at the May Board Meeting as requested by Mr. Pacello.
- Miles between road calls took a dip but is still well within the range of acceptable
 and we will continue to monitor it in the future. This is the first time in a while
 that MATA received a year-over-year increase in preventable accidents but will
 continue to monitor this.
- CEO Rosenfeld updated the Board on his monthly meetings and events for April 27 through May 21, 2018.

Questions: Mr. Vergos asked if we expect the city budget to be equal to what it was last year. Mr. Rosenfeld stated we have been told that we can expect less that last year.

 a) Resolution to Award a Contract to Precise Contract Concrete Works, LLC dba Precise Contracting for the Section 5310 Curb Ramp Improvement Project – Res. No. 18-18

Mr. Rosenfeld presented this resolution to the MATA Board. This is part of our ongoing program in the distribution of the 5310 dollars for partnering with the City of Memphis to improve a ramp access at bus stops along our service corridors. A segment of this has gone through the biding process and the contractor is a 100 DBE and MATA is recommending approval of this resolution.

Mr. Pacello moved that Res. No. 18-18 be approved. Ms. Williams seconded the motion. MOTION CARRIED

Resolution to Award a Contract Under the Section 5310
 Program to Mid-South Bus Center for the Purchase of Seven
 Side-Loading and Three Rear-Loading Wheelchair-Accessible
 Vans – Res. No. 18-19

Mr. Rosenfeld presented this resolution to the MATA Board. This is part of our ongoing Equipment Replacement Program for Paratransit Program. The 5310 money is also used for

some of our partnership with local taxi companies to provide ADA service outside our service hours. These 10 vehicles will go to a myriad of companies in our area and we will be coming back hopefully in our next Board meeting with results of our next bid.

Ms. Williams moved that Res. No. 18-19 be approved. Mr. Vergos seconded the motion. MOTION CARRIED

Questions: Mr. Gibson asked how we know if these companies are doing with the vehicles what they are supposed to be doing in providing the hours for paratransit service and are we getting reports back on how these vehicles are being used. Mr. Rosenfeld stated the utilization is probably not where we would like it to be, but it is there. These companies report directly to MATA, not the ADA. Mr. Pacello asked is part of the data that we collect the percentage of rides on the vehicles coming through MATAplus or just regular course of their business. Mr. Lancaster stated for Metro Advantage that is just from using them as taxis whether they use the ramps or not. When we do use the taxis company for supplemental MATAplus service, those numbers are reported in the MATAplus numbers.

FINANCIAL REPORT Bernhard Rudolph, CFO March 2018

Revenue was ahead of budget \$1.5MM due to the additional \$2.5MM that we received from the City of Memphis. This is not going to happen next year but we are pleased that we received it this year. Passenger fares increased \$11,000 over the same month the prior year. Actual expenses were over budget by 5% due to Trolley, Central Station and Bus Maintenance. Cash flow is about \$300,000 unfavorable to last year due to the \$6MM Bridge Funding we received from the City of Memphis, which should carry us over to the next budget year. Mr. Rosenfeld stated some of our Operating expense variances are fuel prices increased; miles increased, and some additional maintenance expenses relative to Hybrid buses that had to be repaired to help keep as much service on the streets as possible. Also, Healthcare cost is up about \$1MM over the last year. This ended the Financial Report.

Chairman Healy recognized Councilwoman Swearengen, who was present on behalf of some concerns that were shared with the Memphis City Council at the meeting on Tuesday April 24, 2018. A group of persons with disabilities attended the Council meeting and shared their concerns regarding customer service and the difficulty of getting appointments with MATAplus. Councilwoman Swearengen stated some of their concerns are they do not receive calls back after leaving a message on the automated system. The calls go as far back as three weeks and still they have not been contacted. Councilwoman Swearengen stated everyone deserves a quality of life. Councilwoman Swearengen asked that MATA would be more responsible in responding to the citizens of Memphis, especially persons with disabilities. The Memphis City Council has asked to receive feedback at the next Council Meeting in two weeks.

Mr. Rosenfeld worked with staff and put together a PowerPoint Presentation for the MATA Board as well as for Memphis City Council. He stated that MATA is committed to high quality passenger experience.

There have been issues the past couple of months due to some staffing problems. MATA conducted a recent job fare and recruited about 50 potential candidates that will be joining MATA's program. Chairman Healy, as well as Mr. Vergos stated that we have got to figure this out and do commit to the two-week response that was asked of MATA. Councilwoman Swearengen thanked MATA for the commitment.

SPEAKERS

- Mr. Bouregard Frierson, 2715 Deadrick St., Memphis, TN 38114 Mr. Frierson is asking
 MATA to take his request for a bus to come closer to Deaderick Street as there is a lot of
 senior citizens that live on that route. He is a senior citizen and has to walk a long distance
 to catch that bus to take him to the clinic.
- Ms. Juanita Brooks, P. O. Box 111162, Memphis, TN 38111 Ms. Brooks had a concern about none-service dogs being on the buses, as well children are cussing the bus drivers and threatening their lives. Bus drivers are rude as well and will pass you up passengers. There needs to be a change on these MATA buses and people need to consider what the bus drivers go through.
- Ms. Cynthia Bailey, MBRU Ms. Bailey's concern was about operator's protocol and
 policies when incidents happen on the bus. She also had a concern about the security
 guards at Hudson Transit Center, not being visible outside, they are always inside the
 building. She pleaded with MATA to assure that the security guards spend more time
 outside where most incidents happen before someone is killed again.
- Justin Davis, MBRU Mr. Davis had some three questions. 1) The plans to have trolley fares free for two weeks; 2) Buses running free a few days during MLK50 Commemoration. 3) How much it cost to run the services for free, and where is the money coming from. However, he did state that the free services are appreciated.
- Mary Godwin, 21 Neely St., #604, Memphis, TN Ms. Godwin's concern was with the
 children on the buses and fighting at the terminal and no security is around. She
 mentioned that MATA needs to pull the cameras on the buses to see what's going on
 inside these buses. Again, security is usually nowhere around, and MATA needs to tighten
 up on their security.
- Allison Donald, 1633 Madison Ave. Memphis, TN Ms. Donald stated they are familiar with what the 5310 Grant is all about and with the other transportation companies getting accessible vehicles, but her question is how to be sure that it is going to work. They have all requested these services via taxis before and have been turned down. What do they do when the taxis service tells them they are not available. She stated the real issue is inconsistent service. She also stated that she called three days ahead and was denied a trip and that is against the ADA and against the law and that is what MATAplus is currently doing, breaking the law.
- Nicole Bowen, 1137 Kney, Memphis, TN 38107 Ms. Bowen stated that the MATAplus issues did not just start in April or May, all meetings are documented. Perhaps they are fully staffed in reservations, but when you call in to make a reservation, they might call you back and when they do they tell you they are closed for the day. You are supposed to be able to call the day before and get a reservation, that is no longer the case. It is against the law and against ADA Regulations. It is not only a medical-only service, it is a paratransit and shared transportation service.

Ms. Bowen stated that when management changed that's when the service declined. This is a repeated cycle. Ms. Bowen has also stated in the past that service is taken away from MATAplus and given to Fixed Route for their use, which takes away the MATAplus service.

• Curtis Tillman, National Federation of the Blind, 3323 Bestway Drive, Memphis, TN 38118 Mr. Tillman talked about an issue that was brought up regarding not having enough drivers and how MATA is losing drivers. He stated that MATA considers Fixed Route drivers more valuable than MATAplus drivers. MATAplus drivers have more to deal with on a day-to-day basis and he don't know why they are considered as second-class drivers by being paid lower wages, which is why MATA is losing drivers. He stated that the voicemail system is very inconsistent. He consistently calls the complaint line but will not leave a complaint with anyone that works directly with MATAplus, that way he is assured that his complaint is being tracked because he receives a call back and is given a reference number.

Chairman Healy stated that we take these matters very seriously and we commit to follow up and want to make sure every issue is addressed.

Mr. Gibson agreed with Chairman Healy and stated that we should not be hearing those types of complaints especially in that volume. Mr. Gibson asked if we could possibly get the owners of these companies to develop a reporting system as they are getting a 90% discount and it behooves them to come up with the best and possible on that bid. Mr. Pacello stated we all know there are resource challenges and asked that while MATA is investigating all of this, if staff could report back to the Board to let them know exactly what the breakdown of the situation is. Vice Chairman Healy stated that whatever is reported to the Memphis City Council will be reported to the MATA Board as well. Chairman Healy wants everyone to understanding that the biggest hurdle that we face is funding. We need to join as a united front and figure out how to get this agency funded appropriately and feels that will fix a lot of these problems. Mr. Rosenfeld stated that he truly understands the frustration of the riders especially after the City Council meeting and staff have been meeting consistently to get to the bottom of that processing. These are our customers, they deserve the best service and there is no getting around that we have let them down. Mr. Rosenfeld stated that we will report back to the Board at the next meeting, as well as to the Memphis City Council in a couple of weeks. Ms. Williams thanked MATA and staff for all the hard work put into this to make things better.

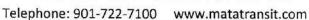

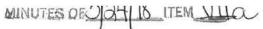

RESOLUTION TO AMEND CONTRACT AWARDED TO MID-SOUTH BUS CENTER FOR SECTION 5310 VANS AUTHORIZED TO BE PURCHASED UNDER RESOLUTION NO. 18-19

WHEREAS, The Memphis Area Transit Authority (MATA) Board of Commissioners authorized a contract be awarded to Mid-South Bus Center for seven Braun side-loading wheelchair-accessible vans for Metro Advantage Cab and three Braun rear-loading wheelchair-accessible vans for Mid-South Ambulatory, Inc. under Resolution No. 18-19 on April 26, 2018; and

WHEREAS, MATA's Staff was notified shortly after the approval that Mid-South Ambulatory, Inc. wanted to purchase Ford Transit vans with more seating for ambulatory passengers instead of regular Braun vans; and

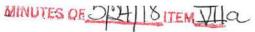
WHEREAS, The unit cost of the Ford Transit rear-loading van with 10 seats and room for one wheelchair is \$49,646 compared to the unit cost of the Braun van at \$37,070; and

WHEREAS, Mid-South Ambulatory, Inc. has informed MATA that they are willing to accept two Ford Transit rear-loading vans at a total cost of \$99,292 instead of the three Braun rear-loading vans at a total cost of \$111,210 and provide the 10% matching share; and

WHEREAS, The Ford Transit vans were included in MATA's solicitation document, and MATA's Staff recommends that the Board authorize this change to the contract with Mid-South Bus Center who has indicated they are willing to make the change.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS That the contract awarded to Mid-South Bus Center for the purchase of seven 2018 Braun side-loading and three rearloading wheelchair-accessible vans at a total contract amount of \$376,720 is amended to include the purchase of seven Braun side-loading wheelchair-accessible vans (\$37,930 each for a subtotal of \$265,510) and two Ford Transit rearloading wheelchair-accessible vans (\$49,646 each for a subtotal of \$99,292) for a total contract amount of \$364,802.

BE IT FURTHER RESOLVED, That Metro Advantage Cab and Mid-South Ambulatory, Inc. shall provide the 10% local share for their vans and enter into a lease with MATA for the vehicles in accordance with FTA policy.

Resolution to Amend Contract Awarded to Mid-South Bus Center for Section

5310 Vans Authorized to be Purchased under Resolution No. 18-19

On April 26, 2018, the MATA Board of Commissioners authorized a contract to be awarded to Mid-South Bus Center for the purchase of seven Braun side-loading wheelchair-accessible vans for Metro Advantage Cab and three rear-loading wheelchair-accessible vans to Mid-South Ambulatory, Inc. under the Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities program.

Following this approval, Mid-South Ambulatory, Inc. asked the MATA Staff if they could change the type of van they are to receive so that it can have more seats for ambulatory passengers. MATA's Staff checked on the price of a Ford Transit van with 10 seats and one wheelchair location per Mid-South Ambulatory's request, and Mid-South Bus Center stated that its cost would be \$49,646. Based upon the amount of funds allotted to Mid-South Ambulatory, Inc. by MATA during the Section 5310 project selection process, they will only be able to purchase two of the Ford Transit vans for a total of \$99,292.

MATA's Staff finds this change to be acceptable and recommends that the Board authorize and amendment to the contract with Mid-South Bus Center so that the two Ford Transit rear-loading vans can be purchased instead of three Braun rear-loading vans.

Mid-South Ambulatory had indicated they will provide the 10% local share for the vans that they receive and enter into a lease with MATA for the vans in accordance with FTA policy.
