MINUTES OF THE EMERGENCY MEETING JANUARY 26, 2017 MEMPHIS AREA TRANSIT AUTHORITY BOARD OF COMMISSIONERS

CALL TO ORDER: An Emergency Meeting of the MATA Board of Commissioners was called to order on Tuesday January 26, 2017 at 4:30p.m. at City Hall, 125 N. Main Street.

The Board convened in Executive Session. MATA General Counsel Bruce Smith informed the Board that on January 25, 2017, Ron Garrison was issued a Misdemeanor Citation on a charge Of Solicitation of Prostitution Near A Church Or School as part of an undercover "sting" operation conducted by the Tennessee Bureau of Investigation (TBI). TBI has not announced the issuance of the Citation to Mr. Garrison and will hold a press conference tomorrow. The undercover "sting" operation is not public and may be ongoing.

Mr. Smith informed the MATA Board that there were legal issues as to Mr. termination of appointment as MATA President/General Garrison's Manager/Chief Executive Officer and of his Employment Contract with Mid-South Transportation Management, Inc. (MTM), including claims the parties could assert against the other. Mr. Smith reported and provided information to the MATA Board as to the legal issues. After MATA's discussions with Mr. Garrison today, Mr. Garrison after consultation with his attorney, resigned as MATA President/General Manager/Chief Executive Officer and from his employment with MTM. Mr. Garrison has executed a Separation Agreement, the terms of which Mr. Smith summarized for the MATA Board. The Separation Agreement contains a full and general release of all claims by Mr. Garrison against MATA, the MATA Board of Commissioners, MTM, the City of Memphis, the Mayor and the Memphis City Counsel.

The MATA Board then convened in open session.
